### REPATRIATION OF SEAFARERS DUE TO THE SITUATION IN UKRAINE

No: MMN-04/2022

- 1. The purpose of this Merchant Marine Notice is to inform that due to the events in Ukraine and taking into account the views of the Maritime Transport Workers Trade Union of Ukraine (MTWTU ITF affiliate) and guidance of Paris Memorandum of Understanding (MoU) and Tokyo MoU, the Panama Maritime Administration has considered it necessary to apply flexibility and pragmatism on the issue of extending periods of service on board ships in these circumstances, taking into account the difficulties that may be encountered in the repatriation of Ukrainian seafarers.
- 2. As both MoUs have indicated, it is acknowledged that the effect on repatriation may not be limited to Ukrainian seafarers but may impact other seafarers caught up in the present situation. The Tokyo MoU noted that the payment of salaries under the MLC 2006 may be difficult due to the impact on the banking system in Ukraine and the wider region. Alternative arrangements may need to be put in place to pay seafarers and facilitate the payment of any allotments to dependents.
- 3. This Administration considers it appropriate to inform that the port States have issued guidelines to deal with the current situation of the Ukrainian seafarers, which should be taken into account by the shipowners and operators regarding of the extensions seafarers' employment agreements (SEA) of seafarers who wish to remain on board and in the cases of seafarers who are willing to return home at the end of their employment contract, for which the shipowners must provide tickets to friendly neighboring countries in the region with enough money for land transport where flights are not available.
- **4.** In case the maximum duration of the seafarers' employment contract (SEA) has expired and an authorization is required for the extension by the flag State, a request must be sent to the email <a href="mailto:seaextension@amp.gob.pa">seaextension@amp.gob.pa</a>. This will only be authorized on a case-by-case basis to address the emergency situation that does not allow seafarers to return home and only with the consent of the seafarer.

- **5.** This Maritime Administration reiterates that any extension granted would require an addendum to the seafarer employment agreement on the same terms and conditions as the underlying contract and must be agreed to by both parties.
- 6. Extension of Seafarers Certificates of Endorsement (STCW)
  - **6.1.** For the extension of endorsements of certificates for Ukrainian seafarers, the requirements set forth in paragraph 5 of the Merchant Marine Notice MMN-03/2020: "Coronavirus and Seafarers employment agreement and Certificates".
